Recalls on Various Flours

If you are starting to stock up on flour and use any of these, please be aware of the following FDA Recalls...

May 28, 2019 - Baker's Corner Flour Recall Expansion

ADM Milling Expands Recall of Baker's Corner All Purpose Flour 5lb Bags Packaged for ALDI in Select States. We reported earlier about this recall, and it was expanded. To see the details, click on this FDA link:

June 13, 2019 - 5 lb. King Arthur Unbleached All-Purpose Flour:

King Arthur Flour, Inc. is voluntarily recalling 14,218 cases of 5 lb. Unbleached All-Purpose Flour due to the potential presence of Escherichia coli bacteria (E. coli). The recalled Unbleached All-Purpose Flour (5 lb.) was distributed through retailers and distributors nationwide.

The only product affected by this voluntary recall is our Unbleached All-Purpose Flour (5 lb.) from these six specific lot codes and three Best Used by Dates, which can be found on the bottom of the side panel, below the nutrition facts panel.

BEST USED BY 12/08/19 LOTS: L18A08A, L18A08B

BEST USED BY 12/14/19 LOTS: L18A14A, L18A14B, L18A14C

June 14, 2019 - Hometown Food Company Issues Voluntary Recall of Specific Lot Codes Pillsbury® Best Bread Flour Due to Possible Health Risk:

Hometown Food Company, in cooperation with ADM Milling Co., today initiated a voluntary recall of two specific lot codes of its Pillsbury® Best 5 lb. Bread Flour due to a potential presence of pathogenic E. coli. The product was manufactured by ADM Milling Co., at the company's mill in Buffalo, NY.

Approximately 4,620 cases of impacted Pillsbury® Best 5 lb. Bread Flour were distributed to a limited number of retailers and distributors in 10 states.

The affected product has the UPC code 051500200315, and the following lot codes and Best-If-Used-By dates:

Kashrut Alerts

June 3, 2019 - Malt-O-Meal, Royal Imports, Kfar Hanina, Israel:

The Orthodox Union certifies some (but not all) Post Malt-O-Meal cereals. The products that are certified have an OU symbol printed directly on the box. Royal Imports, an importer in Kfar Hanina, Israel, is importing products and placing stickers with an OU symbol on those products, whether or not the products are certified. Consumers should not rely on any stickers placed on products imported into Israel unless the OU symbol is also part of the original product packaging. (Source: OU)

June 4, 2019 - Italpasta 7.5-ounce boxes of Macaroni & Cheese from Canada:

Some shipping boxes for Italpasta 7.5 ounce boxes of Macaroni & Cheese, Brampton Ontario have been mislabeled with an unauthorized OU symbol. The Orthodox Union does not certify Italpasta Macaroni and Cheese. Individual 7.5 ounce packages do not bear the OU symbol. (Source: OU)

June 5, 2019 - Princess Nur Viennese Finger Biscuits, Classic Tea Biscuits, Global Foods Importers LLC, 3277 NW 67 St., Miami, FL 33147 has Unauthorized Use of OK Kosher Symbol:

Princess Nur Viennese Finger Biscuits and Classic Tea Biscuits, sold at Fruteria La Hacienda in N. Miami Beach, bear an unauthorized OK Kosher symbol. This company and their products are not certified by OK Kosher Certification. Corrective actions are being taken. (Source: OK Kosher)

June 26, 2019 - Quaker Chewy Granola Bars 58 Count Variety Pack: Many, but not all, varieties of Quaker Chewy Granola Bars are OU certified and bear the OU symbol. Among the non-certified varieties are S'mores and Peanut Butter Marshmallow, which contain gelatin. One type of 58 Count Variety Pack sold online, with UPC # 0 30000 56759 3, contains these two noncertified varieties, but mistakenly bears an OU symbol on the outer package. This is unauthorized. Other types of 58 Count Variety Packs sold online that bear an OU are authorized. (Source: OU)
